Why We Collect Personal Information

We will only collect personal information that is needed to assist in fulfilling the following purposes:

- Verifying user identities;
- Identifying user preferences;
- Meeting regulatory requirements;

- To contact the user (if requested) via contact details;

How We Collect Personal Information

We may collect personal information in various ways, including but not limited to:
